Woods Tennis Center Expansion in the Early Phase of Planning

Kevin Heim, Executive Director of the Woods Park Tennis Center, was our speaker at the September meeting and shared very preliminary information about proposed expansion of the facility. Kevin emphasized that this is just the beginning of the conversation as planning is in the very early phase.

Why is further renovation needed? Kevin shared that programs within the facility have continued to grow in numbers. While there were 26 children & youth involved in programming in 2008, that number has grown to 300 kids enrolled on-site and 1200 citywide. "Taking the game to the community" was the theme of the fundraising that led to the first phase of renovation and could not be more true. Kevin and his team offer tennis lessons at all of the City Rec Centers, all of the Community Learning Centers and nearly anywhere there is gym space, a parking lot or a playground where the game can be played. Prior to the pandemic they offered lessons at a variety of locations and to a variety of groups including the Malone Center, Boys & Girls Club, Lighthouse, El Centro, the Asian Center and the Salvation Army.

Programs for adults have also grown. There is always a wait list for individual lessons, adult and junior group lessons. The outdoor courts are used by all six public and two private high schools and the Center hosts tournaments for high schools and colleges from the entire state. State tennis meets are held at Woods. With the addition of two more Lincoln high schools the need for courts will continue to increase.

Over the past five years Lincoln has lost several tennis courts while participation and demand continues to grow. The number of indoor courts available to the public has dropped from 16 to 10 courts and the community has lost 22 outdoor courts. Tennis courts have been reduced or eliminated at UNL-City

Campus and East Campus as well as at Nebraska Tennis Center that was located at Abbott Sports Complex.

Phase 2 includes the previously approved increase of indoor courts at Woods Tennis Center from 6 to 10 and includes a new proposal for outdoor courts from 12 to 15. The need for increased parking is also in discussion. Currently the parking area is shared by Woods Pool, the Tennis Center and the park.

Of note, the Woods Tennis Center is a non-profit operation that does not receive operating funding from the city. The non-profit has been self-sustaining since 2010. Each year the Friends of Woods Tennis hosts their annual Turkey Pro-Am Fundraiser. The funding raised from this event has provided over 3,500 free racquets to youth who could not afford their own and first time players and over \$250,000 in need-based scholarships for adults and juniors since 2008.

Kevin fielded many questions and provided a diagram of the proposed expansion. WNA expects to have on-going conversations with Kevin about this project. Stay-tuned for more information as the proposal is formalized.

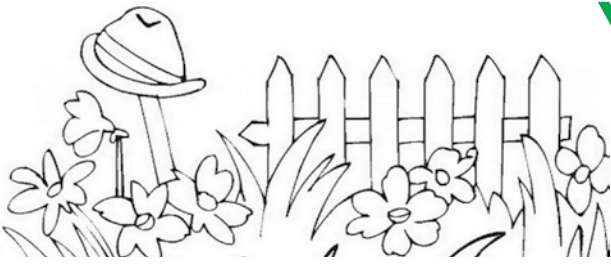

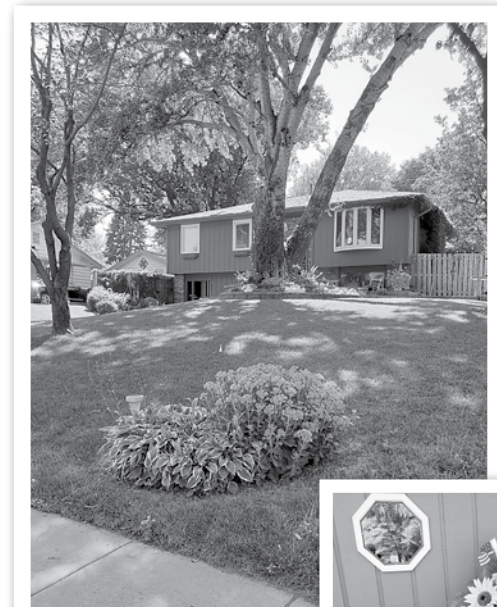

Witherbee Crime Watch Team

Would you like to see improvements in both personal and residential safety in the Witherbee neighborhood?

With the help of the LPD Crime Prevention Officer, Jason Hellmuth, and caring neighbors, I want us to come together and make our neighborhood safer by rejuvenating the Crime Watch Team.

I contacted the Lincoln Police Department Crime Prevention Unit to re-ignite this cause and agreed to serve our neighborhood as the Crime Watch Team Coordinator. Which means: I will be the "connecting point liaison" to the LPD, our Witherbee Crime Watch Team and our neighborhood. I will provide the LPD with a current list of team members and their addresses. I will also coordinate efforts to help the team and our neighbors learn about safety and crime prevention. The Witherbee Crime Watch Team will help neighbors by being the eyes and ears for the LPD and neighbors, while watching and/or reporting on suspicious activities or concerns for neighbors. The LPD offers neighborhoods classes and/or information about crime prevention and safety. It's that simple = If we can learn how & why, if we can learn new methods of crime prevention while working alongside the LPD, we will improve our ability to watch-out for one another. Then we can eliminate one of the biggest elements needed for crime events... "Opportunity."

Would you like to volunteer? Would you like to attend a meeting to learn more about the Crime Watch Team or about specific safety interests? I would like to set up a meeting for the group (Covid Safe) to learn more about Personal Safety, Internet Fraud, Internet Safety, Senior Safety.... Please message me about your interests, let me know if you are willing to volunteer to serve Witherbee neighbors on the Crime Watch Team and I will contact LPD Officer Hellmuth to set a date for additional information.



You can get to know a little about Officer Hellmuth, the LPD Officer who will support our neighborhood effort, on KLNK TV, weekly on channel 8 mid-afternoon.

If you have been a Neighborhood Watch Block Coordinator, please reach out to me. I realize that there may some of you who have been doing this for years. The Witherbee neighborhood has not had a Team Coordinator in the past so this will be a new way to keep us organized.

Currently we have 11 team members serving the Witherbee Crime Watch Team. But we need more people. It would be awesome if we could get a Crime Watch Team Member on every block of the Witherbee neighborhood! If you are interested, I hope you will take a few minutes and complete the form or contact me. Consider this thought; the more neighbors we have involved in neighborhood crime prevention & safety, the stronger, more knowledgeable, Witherbee neighbors will be, to safely protect and look out for each-other



Lincoln Goodwill Announces 9th Annual Neighborhood Challenge Winners

Wetherbee Neighborhood Association takes 3rd Place

Lincoln Goodwill celebrated the 2021 garage sale season by hosting their biggest Neighborhood Challenge yet. With 17 participating associations, Goodwill collected a total of 32,656 pounds of donations!

Every year, Goodwill's Neighborhood Challenge gives Lincoln associations the opportunity to donate their gently used items after garage sales or clean up events. The top three associations win a cash prize to help fund a neighborhood project of their choice.

The Highlands Neighborhood Association took first place this year, donating 4,569 pounds of gently used items after their annual garage sales. Southwood and Wetherbee placed second and third, respectively. Southwood Neighborhood donated a total of 3,387 pounds while Wetherbee was not far behind at 3,135 pounds. As the 3rd place winner, WNA received a check from Goodwill for \$150.00.

Bryan Hurst coordinated the Goodwill dropoff site at our annual clean up in May. Julie Flodman coordinated the donations to Goodwill after our annual garage sale event in June.

Other participating neighborhoods included Briarhurst West, Bicentennial Estates, Wellington Greens, Forest Lake Estates, Stone Bridge Creek, Eastridge, North Hills,

College View, Williamsburg, Wilderness Hills, Vintage Heights, Tierra, Near South and ECCO.

Thanks to the generosity of all of the Neighborhood Challenge donors, Goodwill can continue to connect local job seekers of all abilities and backgrounds to employment opportunities. The sales from Goodwill's retail stores help fund free employment services in the community, like Goodwill's Job Connection Center and other local nonprofits that support their mission.

Goodwill's 10th Annual Neighborhood Challenge registration will open in February 2022. eighbors donated a total of 3,387 pounds.

Update on Tabitha's Proposed Apartment Building Project at 48th & L Street

WNA members have had several meetings regarding Tabitha's proposed development of the InterGenerational (InterGen) Living Community with Tabitha leaders as well as individuals from the City Planning Department and Traffic Engineering. The 130 unit commercial-scale apartment community is planned for the corner of 48th and L Streets.

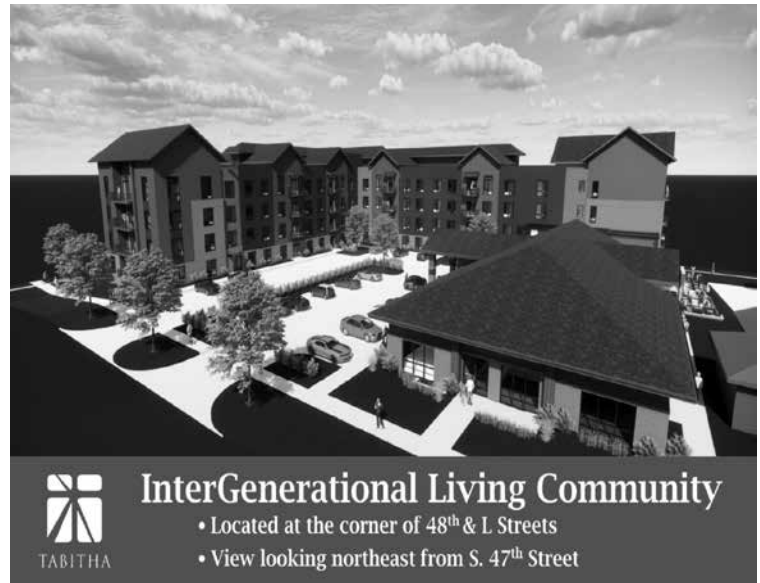
This living community will be moderately-priced housing with some underground parking that would bring together independent seniors (65 +) and Bryan College of Health Sciences students. As part of the funding for this project, an area between 46th and 48th streets, L St to A St has been declared a blighted area.

At a regularly scheduled WNA meeting October 7th, those present approved the position statement submitted by the committee which recommended that we oppose this project. Excerpts from the position statement are below.

The proposed project is the first commercial scale high density residential development within the Witherbee Neighborhood. We take interest in the scale, design, and fit with Witherbee Neighborhood and the impact on public infrastructure. We are concerned about the possible precedent that could be set. Witherbee is a residential neighborhood of 1800 residences, single family and duplex homes with only 12 multiplex buildings the largest of which is 12 apartments.

The proposed project is a 130-unit commercial scale apartment complex set in R-2 zoning. Even with the recent generous expansion of limits for building within R-2, the project as proposed exceeds the expanded standard for height and density while asking for further erosion of the standards for setback and required parking.

The proposed project presents a 'campus friendly' design expanding the existing Tabitha campus. The project fits into the campus by placing parking and a two story community room building on the campus facing sides (south, west). The project's neighborhood facing sides (north, east) are 5-story vertical walls with no transition to the single family homes across the street. The 65-ft height waiver requested covers these walls that



form the neighborhood facing sides of the project along L Street and 48th Street. The project design places the building beyond the buildable boundaries on 48th and on L with setback reduction requests. The only 'transition zone' to the surrounding residential neighborhood consists of public streets.

While we appreciate Tabitha's design elements to construct a building with an outward appearance more friendly to the neighborhood, we object to the overall size and placement of the building. Tabitha has been a good neighbor and we believe the intentions of this project are worthy, specifically offering affordable housing for the moderate income senior market.

However the size of the project and the increase in population density must certainly be considered when evaluating whether the infrastructure in the redevelopment area can support the project. WNA is not anti-growth. WNA is for appropriate scaled development. WNA supported the Tabitha Green Houses on 47th St because they were of an appropriate scale and character for the neighborhood. The position of the WNA is that the proposed building is too large to be compatible with the surrounding neighborhood. Also, until we are assured that supportive infrastructure, such as the water, sewage systems, traffic, and transportation will be evaluated and addressed, we cannot support this project.

The proposed development is on the Planning Commission agenda October 13th and we anticipate it will then move on to the City Council for review in November.
